

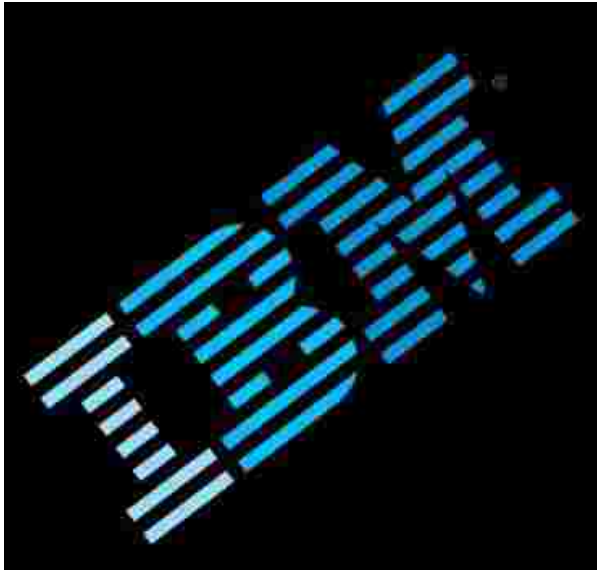

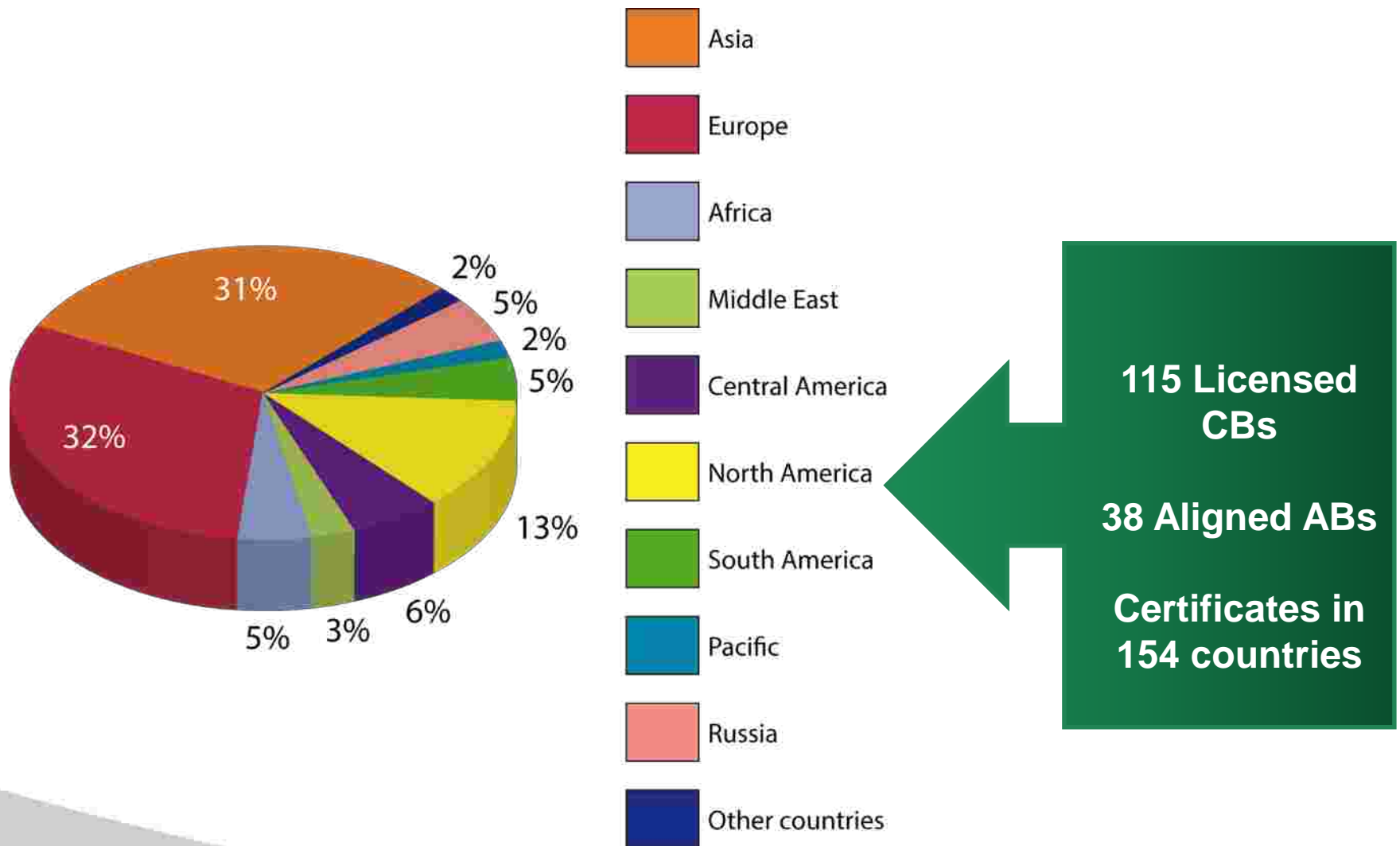

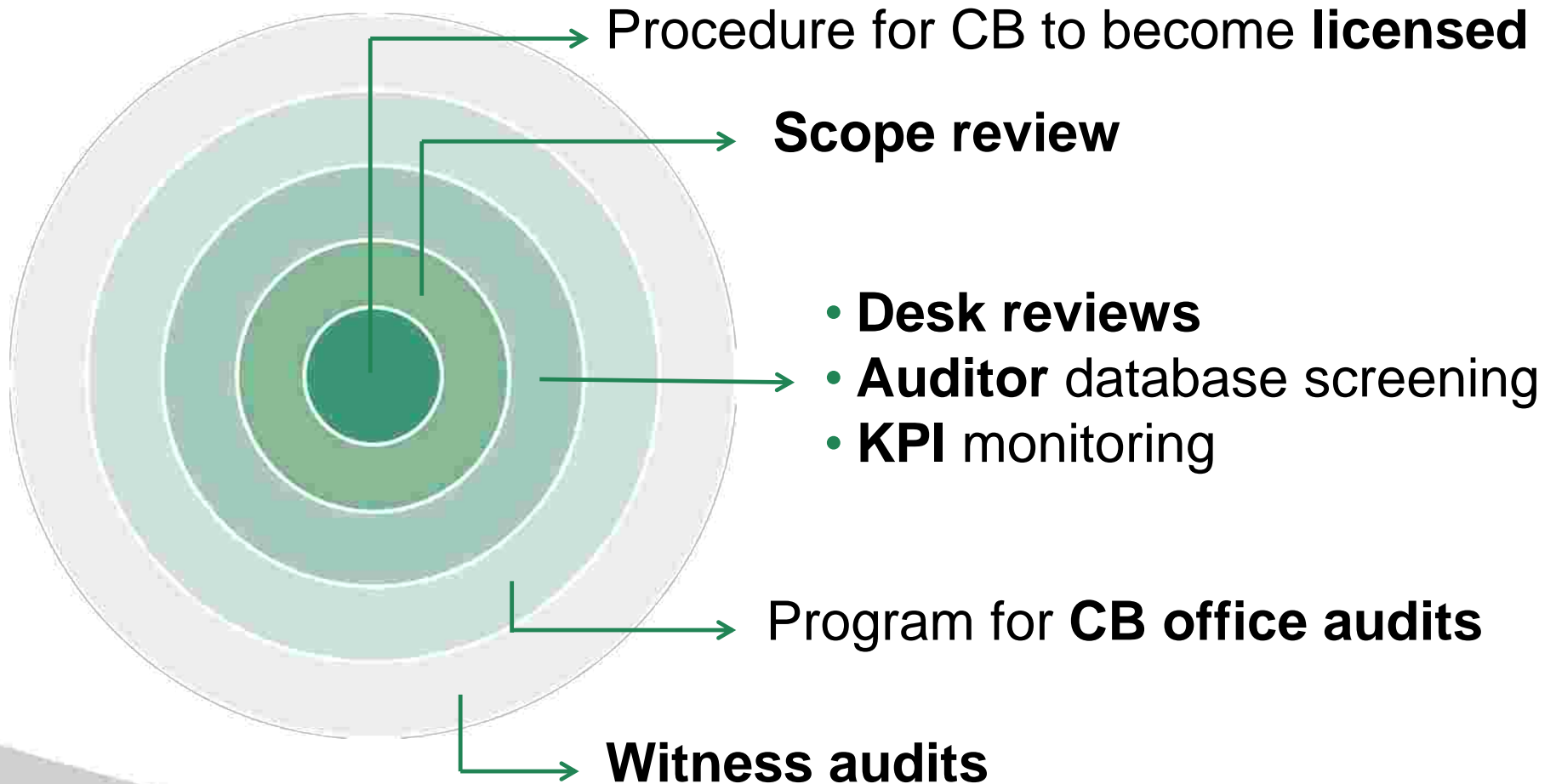
The Entire Food Supply Chain



Key factors

- Good Governance
- Compliance and Control: Integrity Program
- Strong Organization and Finance
- IT- Support
- Global Harmonization

Integrity Program



The Global Food Safety Initiative (GFSI):

- Specifies for the recognition of food safety certification programs to defined requirements in its Benchmarking Requirements.
- Brings together food safety experts within a global network.
- Drives global change through multi-stakeholder projects on strategic issues (eg. auditor competence, regulatory affairs, food safety for small suppliers).

Global Food Safety Initiative

- Benchmarking to v7.1
 - Application approved (Dec17)
 - Self-assessment (Feb18)
 - Desk review (Apr18)
 - Office audit (May18)
- Auditor competence
 - Centralized exam under v7.2
- Multi-site
 - GFSI does not allow multi-site for catering & retail
 - FSSC will research options
